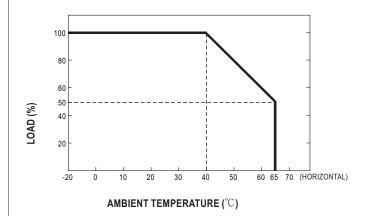

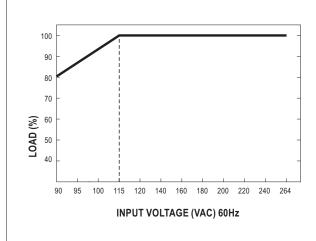
■ Block Diagram



■ Derating Curve



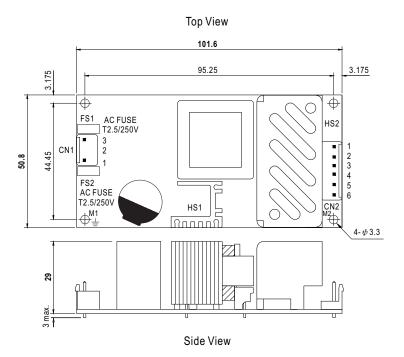
■ Output Derating VS Input Voltage
